

0.1 ZDMP Project Overview

ZDMP – Zero Defects Manufacturing Platform – is a project funded by the H2020 Framework Programme of the European Commission under Grant Agreement 825631 and conducted from January 2019 until December 2022. It engages 30 partners (Users, Technology Providers, Consultants and Research Institutes) from 11 countries with a total budget of circa 16.2M€. Further information can be found at www.zdmp.eu.



0.2 Deliverable Purpose and Scope

In this task, the dissemination materials will be designed/produced – for external and internal use – including banners, brochures etc. Most importantly, the ZDMP website and portal will be implemented and maintained, based on the analysis of the project’s needs. The project website will contain up to date information on the progress of the ZDMP project. Furthermore, it will be used to publish public deliverables and provide information on ZDMP events, publications, and exploitable results. The project’s portal will consist of a private area to encourage the sharing of documents, knowledge, and the collaboration among the members of the ZDMP project. It will also contain a web-based document repository, in which work-in-progress publications and deliverables will be shared. Furthermore, it will provide access to an underlying source code version control repository used in the ZDMP development linked to WP1. The ZDMP Portal will also offer direct access to different social networks (eg Facebook, LinkedIn, etc) and Animated/Real-life YouTube videos related to ZDMP Project which will be created. The website (in basic form) will be up and running on day 1 of the project (through partner’s own resources) and be developed more completely mostly within the first 2 months. The website will also consider the demands of the WP1 management work package, project management needs (eg

a web-based document repository in the restricted area, list server) and the Technical Management needs for eg bug tracking

1 Website

The ZDMP website was up-and-running, in an extremely simplistic form, before the official start of the project although without cost to the project. Within the first week of the project, a more comprehensive site was developed with most current content being available at the end of M1. It has been added to over time as well as updates made including from multi-beneficiary input it will continue to evolve over time with more major updates especially for the subcalls and ongoing results. As prescribed, it will fulfil the function of providing:
